**THE SIERRA LEONE METEOROLOGICAL AGENCY
(AMENDMENT) ACT, 2022.**

Short title.

**Being an Act to amend the Sierra Leone Meteorological
Agency Act, 2017 and to provide for other related matters.**

ENACTED by the President and Members of Parliament in this
present Parliament assembled.

Amendment
of section 1
and Act No. 8
of 2017.

1. Section 1 of the Sierra Leone Meteorological Agency Act, 2017 is amended by repealing and replacing the definition of "Minister" with the following new definition-

"Minister" means the Minister of the Environment.

Amendment
of section 3
of Act No. 8
of 2017.

2. Section 3 of the Sierra Leone Meteorological Agency Act, 2017 is amended by repealing and replacing subsection (2) thereof with the following new subsection -

"(2) The Board shall consist of a Chairman and the following other members, who shall not be below the rank of a Director, representing the following institutions-

- (a) The Ministry of the Environment;
- (b) The Ministry of Finance;
- (c) The Ministry of Planning and Economic Development;
- (d) The Ministry of Fisheries and Marine Resources;
- (e) The Ministry of Lands and Country Planning;
- (f) The Ministry of Transport and Aviation;

- (g) The Ministry of Energy;
- (h) The Ministry of Agriculture;
- (i) The Ministry of Water Resources;
- (j) The Ministry of Defence;
- (k) The Sierra Leone Airports Authority;
- (l) The Environment Protection Agency;
- (m) The Sierra Leone Maritime Administration;
- (n) The Office of National Security; and
- (o) 2 persons, one who shall be female, with proven knowledge and experience in meteorology appointed by the President on the recommendation of the Minister subject to the approval of Parliament."

3. Section 18 of the Sierra Leone Meteorological Agency Act, 2017 is amended by repealing and replacing that section with the following new section -

Amendment of section 18 of Act No. 8 of 2017.

"Departments of Agency.

18. The Agency shall have the following departments and administrative divisions-

- (a) Aviation Meteorology Department;
 - (b) Agro-Meteorology Department;
 - (c) Marine Meteorology Department;
 - (d) Hydro-Meteorology Department;
 - (e) Finance and Administration Department; and
 - (f) Climate Change Department."
