PREAMBLE: These Bye-Laws are made by the Civil Aviation Authority of Botswana with the approval of the Minister of Transport and Communications under Section 8 (2) of the Civil Aviation Act, 2011.

CITATION:

These Bye Laws may be cited as the Civil Aviation Authority of Botswana (Documents to Be Carried Onboard Aircraft Registered in Botswana) Bye Laws.

1. PURPOSE

The purpose of this Civil Aviation Bye-Law (CABY) is to clarify the requirements for on documents to be carried by aircraft registered in Botswana as laid down in Regulation 10 of the Civil Aviation (Operation of Aircrafts Regulations) 2013 and the ICAO Annex 6 recommendations.

2. APPLICABILITY

This Bye-Law shall apply to all aircraft registered in Botswana and engaged in international navigation.

3. EFFECTIVITY

This Civil Aviation Bye-Law (23-2014) shall become effective immediately.

5. REQUIREMENTS

- 5.1 Civil Aviation Authority of Botswana (CAAB) requires the operators of Botswana registered aircraft to carry on board the aircraft a certified true copy of the Air Operator Certificate and its Operations Specifications.
- 5.2 Botswana Air Operator Certificate (AOC) holder shall ensure that on any flight for the purpose of commercial air transport and the flight is international air navigation, the aircraft shall carry a certified true copy of the air operator certificate and its operations specifications.
- 5.3 An ICAO Member State complying with the Standard shall expect a Botswana AOC holder, operating into their territory, to have a certified true copy of the AOC and its Operations Specifications available on board during a ramp check.
