### PROCLAMATION NO. 216/2000

### A PROCLAMATION TO AMEND THE PROPERTY MORTGAGED OR PLEDGED WITH BANKS PROCLAMATION

WHEREAS, it has become necessary to amend the  
Property Mortgaged or Pledged with Banks Proclamation No.  
97/1998;

NOW, THEREFORE, in accordance with Article 55(1)  
of the Constitution of the Federal Democratic Republic of  
Ethiopia, it is hereby proclaimed as follows:

#### 1. Short Title

This Proclamation may be cited as the “Property  
Mortgaged or Pledged with Banks (Amendment)  
Proclamation No. 216/2000”.

#### 2. Amendment

The Property Mortgaged or Pledged with banks  
Proclamation No. 97/1998 is hereby amended as follows:

1) The correction made to Article 3 of Proclamation  
under paragraph (1) of Corrigendum No. 1/1998 is  
hereby deleted and the phrase “or if no buyer  
appears at the second auction, to acquire the  
property at the floor price set for the first auction and  
have the ownership of the property transferred to it”  
is inserted after the word “buyer” on the eighth line  
of the Article.

3. *Effective Date*  
This Proclamation shall come into force as of the 6<sup>th</sup> day of July, 2000.
