## **MERCURY LAW, 1989**

IN pursuance of the Provisional National Defence Council (Establishment) Proclamation, 1981 this Law is hereby made:

1. Any person who

Possession etc. of merwithcury out licence.

- (a) imports any quantity of mercury into the country; or
- (b) has in his possession or buys, sells or transfers any mercurv.

except under a licence issued under this Law shall be guilty of an offence and shall on conviction be liable to a fine not exceeding (2,000,000.00 or to a term of imprisonment not exceeding two years or to both.

2. (1) The Secretary for Trade may issue a licence to any person Power to authorising him to, import into the country, possess, buy, sell or deal grant and in mercury whiest to such coultions are the provided in the such as in mercury, subject to such conditions as may be specified in the licence. licence.

(2) The Secretary for Trade may, at arytime cancel any licence issued by him under this Law if he is satisfied that-

- (a) the licensee is in breach of any of the terms and condi-
- tions of the licence or this Law; or (b) it is in the national interest to do so.

3. Any person who---

- Buying and transferring (a) buys or receives any mercury from a person not authorised to sell or deal in mercury; or mercury from or to
- (b) sells or transfers any mercury to a person not authorised sed person. to buy or have possession of mercury,

shall be guilty of an offence and shall on conviction be liable to a fine not exceeding \$\vec{\vec{2}}\$,000,000,00 or to imprisonment for a term not exceeding two years or to both.

4. (1) Notwithstanding anything contained in any enactment to Small-scale the contrary licensed small-scale gold miners may purchase from gold miners licensed mercury dealers such reasonable quantities of mercury dealers such reasonable licensed mercury dealers such reasonable quantities of mercury as to possess may be shown to be necessary for the purpose of their mining opera- mercury. tions.

(2) Small-scale gold miners shall observe good mining practices in the use of mercury for carrying out mining operations.

(a) sells or deals in mercury;

Offences and punishment.

- (b) is found to be in possession of more mercury than he reasonably requires for his mining operations; or
- (c) does not observe good mining practices in the use of mercury for his mining operations,

shall be guilty of an offence and shall on conviction be liable to a fine not exceeding & 2,000,000.00 or to imprisonment for a term not exceeding two years or to both.

Cancella- tion of licence by yourt and forfeiture.	6. (1) The court before which any person who holds a mercury licence is convicted of an offence under this Law may order such licence to be cancelled.
	(2) Any quantity of mercury with respect to which an offence has been committed under this Law shall by order of the court be forfeited to the State.
Burden of proof.	7. In any proceedings under this Law, the burden shall be on the person charged for dealing in or possessing mercury to prove that he holds a valid licence to possess or deal in such mercury.
Repeal.	8. The Mercury Ordinance (Cap. 184) is hereby repealed.
Interpre- tation.	9. In this Law unless the context otherwise requires— "mercury" means the metal known as mercury or quick silver.
