(c) facilitate the assigning of the Huduma Namba and issuance of the Huduma card to a resident individual.

(a) appear in person before a deside nated registration officer; (b) provide particulars under 1) of the Act; (c) avail any other specific cumentary proof. Enrolment of 12. (1) Aminor maybe enrolled into the XHMS by appearing before minors. a designated registration officer accompanied by a parent or a guardian. (2) The parent or guard present documents in support of age and (a) citizenship of a minor; (b) consent to the enrollment of the minor by embossing a thumb print or a signature on the enrolment form. A newborn shall be enrolled into NIIMS immediately upon registration of a birth. 13. (1) The Principal Secretary shall, upon examining the information provided by the applicant, ----(a) assign a Huduma Namba to the individual within thirty days of application; and

(b) notify the individual of the successful enrolment.

- (2) Where an applicant is not enrolled, the Principal Secretary shall communicate in writing to the applicant and provide—
  - (a) reasons for such decision; and
  - (b) right of review or appeal available to the applicant.

Issuance of Huduma card. **14.** (1) The Huduma card shall be issued to an individual who has been assigned a Huduma Namba within thirty days from the date of such assignment.

(3) Despite paragraph (1), a minor is only digible to be issued with a minors' Huduma card upon—

- (a) attaining the age of six years, and
- (b) taking of the required biometric data.
- (4) The initial issue of the Huduma card to a citizen is free of charge.
- (5) An individual whose Huduma card is lost, worn out, or tampered with shall apply for a replacement and pay a specified fee.
- 15 (1) An enrolled resident individual may update their particulars under NIIMS by notifying a designated registration officer of any change in the particulars.
  - (2) Upon the receipt of a notification of change of particulars under paragraph (1), the designated registration officer shall verify the information provided and update the NIIMS database.
- **16.** The production of any document outlined under section 9A 2(d) of the Act shall rely on foundation data under the NIIMS database.
