## THE TOURISM ACT

(No. 28 of 2011)

IN EXERCISE of powers conferred by section 105 of the Tourism Act, 2011, the Cabinet Secretary for East African Affairs, Commerce & Tourism makes the following Order:—

## THE TOURISM LEVY ORDER, 2015

- 1. This Order may be cited as the Tourism Levy Order, 2015.
- 2. There shall be paid by the owner of tourism activities and services specified in the Ninth Schedule of the Tourism Act, 2011 under class "A" and "B" enterprises, a levy at the rate of two per centum of the gross receipts derived from their monthly sale of food, drinks, accommodation and all other services.
- 3. Every owner shall maintain or cause to be maintained a monthly record in the form set out in the Schedule.
- 4. The original form of the record maintained under paragraph 3 shall be submitted to the Board together with the levy payable for that month on or before the tenth day of the following month.
- 5. For purpose of this Order, the word "services" has the meaning assigned to it under section 2 of the Value Added Tax Act, 2013.

6. The Catering Training and Tourism Development Levy Order, 2000 is revoked.

7. Despite the provisions of paragraph 6, any authorization, charge, fee or notice under force at the commencement of this Order, until expiry, shall have effect as if issued or paid under this Order.
