#### THE RETIREMENT BENEFITS ACT

(No. 3 of 1997)

IN EXERCISE of the powers conferred by section 55 of the Retirement Benefits Act, 1997 the Cabinet Secretary for the National Treasury and Planning makes the following Regulations—

# THE RETIREMENT BENEFITS (FORMS AND FEES) (AMENDMENT) REGULATIONS, 2020

- 1. These Regulations may be cited as the Retirement Benefits Citation. (Forms and Fees) (Amendment) Regulations, 2020.
- 2. The Retirement Benefits (Forms and Fees) Regulations, 2000, in these Regulations referred to as the "principal Regulations", is amended by inserting the following new regulation immediately after regulation 14—

14A. A return on the quarterly record of contributions for an Umbrella Retirement Benefits Scheme in accordance with regulation 22 of the Retirement Benefits (Umbrella Retirement Benefits Schemes) Regulations, 2017 shall be in Form R3 set out in the First Schedule to these Regulations.

- 3. The First Schedule to the principal Regulations is amended—
  - (a) in Table G-
    - (i) by inserting the words "Exchange Traded Funds" immediately after the word "category" appearing in item
    - (ii) by adding the words "and Exchange Traded Funds" at the end of item 5;
    - (iii) deleting the description of item 9 and substituting therefor the following new description—

"Immovable property in Kenya; Property funds, Unit Trust Schemes incorporated in Kenya or collective investment schemes incorporated in Kenya and approved by the Capital Markets Authority reflecting this category".

(b) by inserting the following new Form R3 immediately after Form R2—

## THE CATTLE CLEANSING ACT

(Cap. 358)

PRESCRIPTION OF EFFECTIVE TICK DESTROYING AGENT

IN EXERCISE of the powers conferred by section 2 of the Cattle Cleansing Act, the Director of Veterinary Services prescribes the preparation, the details of which are specified in the Schedule, to be an effective tick destroying agent for purposes of the Act.

### SCHEDULE

A suspension in water of Cychlotix<sup>®</sup> 55% Emulsifiable Concentrate (EC), containing 5% Cypermethrin and 50% Chlorpyrifos when such a suspension is used for cattle cleansing by hand spraying only at intervals of not more than seven days.
