[5th March 1993] Commenceme

THE FEDERAL MILITARY GOVERNMENT hereby Acts as follows:

1. As from the commencement of this Act all the properties specified in the second column to the schedule to this Act, being properties forfeited to the Federal Government and LN. 33 1778. some State Governments under the Public Officers (Forfeiture of Assets) order 1977 and the Public Officers Forfeiture of Assets) Order 1978 are hereby released to the persons named in the first column to the schedule to this Act.

Release of properties.

2. Accordingly, all the rights, interests, obligations and liabilities of the Federal Military Government or a State Government in the properties referred to in section 1 of this Act, shall by virtue of this Act and without any further assurance be vested in the persons specified therein.

Vesting of rights, etc

3. This Act may be cited as the Forfeiture of Assets (Release of Certain Forfeited Properties, Etc.) Act 1993. Citation
