NIGERIA AIRWAYS LIMITED (APPOINTMENT OF
SOLE ADMINISTRATOR) ACT

An Act to make provision for the appointment of a Sole Administrator to take charge as the chief executive of the Nigeria Airways Limited to perform the duties of the Managing Director and the Board of Directors of the Company. 1988 No. 44.

[8th January, 1988] Commence-

1. Notwithstanding the provisions of the Statutory Corporations (Modifications, etc.) Act or any other enactment or instrument (including the Articles and Memorandum of Association of the Nigeria Airways Limited), there shall be for the Nigeria Airways Limited a Sole Administrator who shall be appointed by the President, Commander-in-Chief of the Armed Forces. 2. The Sole Administrator shall—
(a) be the chief executive of the Nigeria Airways Limited;
(b) perform the duties of the Managing Director and of the Board of Directors of the Nigeria Airways Limited; and Functions of
the Sole
Adminis-
trator.



(c) perform such other functions as the President, Commander-in-Chief of the Armed Forces may, from time to time, deem fit in the circumstances.

Short title.

3. This Act may be cited as the Nigeria Airways Limited (Appointment of Sole Administrator) Act.

APPOINTMENT OF DIRECTOR

1. The President shall appoint a Director of the Nigeria Airways Limited to perform the duties of the Director of the Nigeria Airways Limited and the Board of Directors of the Nigeria Airways Limited.

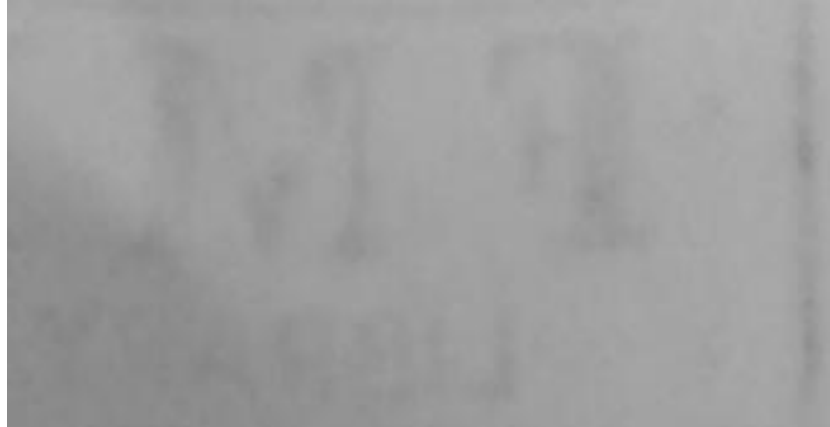
NIGERIA AIRWAYS LIMITED (APPOINTMENT OF SOLE ADMINISTRATOR) ACT
