
**GUIDELINES FOR THE IMPLEMENTATION OF TAX RELIEF MEASURES IN
TARABA STATE TO MITIGATE THE EFFECTS OF COVID-19 PANDEMIC**

You may wish to be informed that His Excellency, The Executive Governor of Taraba State Arch. Darius Dickson Ishaku has granted approval for the implementation of some tax relief measures to mitigate the effect of Covid-19 to Individuals, Tax Payers and Businesses in Taraba State.

This approval is contained in the announcement and press release issued out on the 17th June, 2020 by the Honourable Commissioner of Finance Taraba State, Dr. Adi Jesse Ashumate.

In view of this development, a comprehensive guideline has been developed and adopted by the Taraba State Internal Revenue Services for the implementation of the Tax relief measures, you are therefore directed to strictly comply with the guidelines and also disseminate this information to all our partners and stakeholders under your jurisdiction.



**GUIDELINES FOR THE IMPLEMENTATION OF TAX RELIEF MEASURES IN
TARABA STATE**

Find below the guidelines for the implementation of the Tax Relief Measures in Taraba State.

- i. Ensure that all Tax payers both individuals and organizations are served with form 'A'
- ii. Returns filed between 30th March, 2020 to 30th June, 2020 are not to be charged any late filing interest and penalties.
- iii. Encourage all Tax Payers to patronize our electronics payment platforms to ease their transactions with the service.
- iv. All informal sector Tax Payers are entitled to 50% reduction in their total Taxes if payments are made on or before 31st December, 2020.
- v. All Tax Payers who have tax arrears as the result of Back Duty Assessment during the Covid-19 period are entitled to 50% waiver if the payments are made on or before 30th September, 2020.
- vi. All interests and penalties arising from (v) above are to be waived for those who settled their liabilities before or on the 30th September, 2020.
- vii. Payment of Withholding Taxes (WHT) Timeline of 21st day is extended to the last day of the month following the month of deduction.
- viii. Payment of PAYE timeline of 10th day is extended to the 21st day of the month following the month of deduction.
- ix. Returns received after 30th June, 2020 will be subjected to late filing penalties and interests respectively.
- x. All Tax officers are to keep proper records of reliefs and payment made during the period covered under COVID-19 lockdown.
- xi. All Tax Officers are to ensure that all un-registered Tax Payers are registered and issued with TIN accordingly.

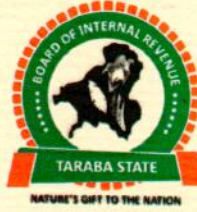



GUIDELINES FOR THE IMPLEMENTATION OF TAX RELIEF

MEASURES ON THE ROAD TAX SECTOR IN TARABA STATE

- i. The on-going enforcement of new number plates has been suspended till 31st October, 2020. But however, they are to be enlightened that the enforcement will continue after 31st October, 2020.
- ii. The enforcement of National Drivers License should take cognizance of the period when then NDL offices were on lock-down.
- iii. All expired vehicle particulars should be given a grace period of three months.
