FINANCIAL HIGHLIGHT FOR THE YEAR 2017

he Yobe State Government budgeted a total expenditure of \\$2,566,317,000 for the year 2017. This made up of Recurrent Expenditure of \\$44,363,454,000 and Capital expenditure of \\$38,202,863,000. The expenditure is expected to be financed by Recurrent Revenue of \\$40,831,017,000 and Capital Receipts of \\$41,735,300,000.


During the year under review, the State Government's actual Recurrent Revenue was \\$55,502,369,320 while actual Capital Receipts was \\$8,255,000,000 representing 87% and 13% performance respectively.

Actual Recurrent Expenditure during the year was ₹39,899,149,404 while actual Capital Expenditure was ₹28,454,358,798 representing 58% and 42% performance respectively.




Analysis on Budget and Actual Revenue




Actual Revenue




Analysis on Budget and Actual Expenditure




Actual Expenditure




Analysis on Budget and Actual Expenditure by Sector

GENERAL PURPOSE OF THE FINANCIAL STATEMENT

he General Purpose Financial Statements (GPFS) is to give an overview of the Financial position and Cash resources of the Yobe State Government of Nigeria as at 31st December, 2017 as well as give a summary of purpose to which the resources received during the year was put into.

STATEMENT OF ACCOUNTING POLICIES

The General Purpose Financial Statements are prepared under International Public Sector Accounting Standard (IPSAS) Cash Basis of Accounting that recognizes transactions and events only when cash (including cash equivalent) is received or paid within the year under review. The GPFS are prepared under the historical cost and convention and in accordance with IPSAS and other applicable Standards. In addition GPFS are compliance with the provision of the Financial (Control and Management) Act 1958 now CAP 144 LFN, 1990, the Financial Regulations (2000) and other known legal requirements.






Analysis on Budget Allocation and Actual Expenditure by Function
