Interpretation

- 2. In this law unless the context otherwise requires:-
- "House of Assembly" means Yobe State House of Assembly;
- "Governor" means the Governor of Yobe State;
- "State" means the Yobe State of Nigeria;

Supplementary Appropriation of N659,000,000 as Recurrent Expenditure

3. The sum of Six Hundred and Fifty-nine Million Naira set out in the first schedule to this law shall be appropriated for recurrent expenditure under ECO Code 0102, 0406, 0201, 1007 and 0202 as fully set out in the first schedule to the Supplementary Appropriation Law, 2020.

Supplementary Appropriation of ₩5,216,000,000 as Capital Expenditure

3. The sum of Five Billion, Eight Hundred and Seventy-five Million Naira set out in the schedule to this law shall be appropriated for capital expenditure under ECO Code 0132, 0202, 0102 and 0105 as fully set out in the second schedule to the Supplementary Appropriation Law, 2020.

Manner and Purpose of Appropriation of N5,875,000,000.00 4. The sum of Five Billion, Eight Hundred and Seventy-five Million Naira being the total sum set out under Code 0102, 0406, 0201, 1007, 0202 and 0132, 0202, 0102 0105 in the first and second schedules to this law shall be appropriated for purpose and in manner expressed in the schedules hereto.

Life Span of the Appropriation

5. Monies appropriated under this law by the State shall lapse on the 31st day of December, 2020.
