A LAW TO PROVIDE AND DEFINE THE SOURCES OF THE REVENUE FOR THE YEAR 2021

Date of Commencement (15 -1-21)

BE IT ENACTED by the Yobe State House of Assembly as follows:

Citation and commencement

Sources of Revenue for the

2. The sources of Revenue for the State, which shall be used for the services of the State including the Statutory Allocation shall be as set out in Heads/Codes of the schedule hereto 11010101 - 13020301 and 41020101 respectively.

General and Collection

3. The Yobe State Board of Internal Revenue shall pursue and collect all revenues due to the State as set out in the schedule hereto and pay same into the Consolidated Revenue Fund of the State provided that revenue due to the State on account of Statutory Allocation and Value Added Tax receipts shall be pursued and collected by the Commissioner for Finance and such Revenue shall form part of the Consolidated Revenue Fund of the State.

Utilization of Fund

4. All Revenues paid into or that forms part of the Consolidated Revenue Fund of the State shall be utilized in accordance with the provisions of the Appropriation Law 2021.
