BE IT ENACTED by the House of Assembly of Kaduna State as follows:

Enactment

1. This Law may be cited as the Kaduna State Local Government Councils Appropriation Law, 2016.

Short Title

Commencement

3. Any sum not exceeding the amount specified in the column of the Schedules in respect of the 23 Local Government Councils totalling Forty Billion, One Hundred and Ninety Three Million, Six Hundred and Forty Eight Thousand, Nine Hundred and Eighty Nine Naira, Two Kobo Only (¥40,193,648,989.02) set forth opposite the heads of expenditure specified in the Schedule herein shall be expended during the year ending the Thirty First December, 2016 in the manner as provided under the Kaduna State Local Government Law.
