A LAW TO SUBSTITUTE THE KADUNA STATE TRANSPORTATION, TRADE AND SLAUGHTER OF DONKEYS (PROHIBITION) LAW NO. 2 OF 2000



Kaduna State of Nigeria Law No.....8 2018 (16th February 2018) Date of Commencement BE IT ENACTED by the House of Assembly of Kaduna State as Enactment This Law may be cited as the Kaduna State Donkeys short tittles Slaughtering, Consumption and Transportation (Prohibition) February 2018. In this, Law unless the context otherwise requires: Interpretation "Commissioner" means the Commissioner responsible for matters relating to Agriculture; "Director" means the Director responsible for Veterinary matters in the Ministry responsible for Agriculture in the State;

"Governor" means the Executive Governor of Kaduna State;

"Meat" means the flesh, skin and, or any part of a donkey; or as may be determined by the Veterinary Officer; and

"State" means Kaduna State of Nigeria;

4. Any person who:

Prohibition of Slathering of Donkevs

- Unlawfully slaughters, kills or causes to be slaughtered or (a) killed any donkey within the State;
- Knowingly has in his possession any quantity of meat (b) of a donkey; or
- Sells or offers for sale or causes to be sold any Ouantity of meat of a donkey, shall be guilty of an Offence.
- 5. Whosever moves or carries or causes to be moved or carried, Prohibition of Movement any donkey, for the purpose of slaughtering for human of Donkeys consumption, commits an offence.

- Any person who unlawfully moves or carries or caused to be Penalty 6. moved or carried, a herd of donkeys without permit in a motor vehicle within the State shall be guilty of an offence.
- 7. (1) Any person who intends to transport donkeys from the State Permit shall obtain a permit prescribed in the schedule hereto from the Director of Veterinary Service or any other Officer authorized by the Director or the Commissioner.

- The Director or authorized Veterinary Officer acting in (2)that behalf shall not issue any permit under this Section unless satisfied that such movement or carriage is not for the purposes of slaughtering for human consumption.
- (3) Notwithstanding the provisions of the slaughter stock (Control and Taxation) Law Cap 142 Laws of Kaduna State 1991 any person who intends to transport donkeys shall pay the sum of \$\\$1,000.00 per donkey as fee to the Director or any authorized Veterinary Officer acting in that behalf.
- The holder of a permit issued under this law, shall on (4) demand by a Police Officer or any person authorized by the Director of Veterinary Services, produce his permit for inspection, and shall give any information required from him

- (5) A permit issued under this Law shall be for a single journey within the period specified therein.
- Any person who commits an offence under this Law shall be Penalty 8. liable on conviction to:
 - for the first offence, to a term of imprisonment of not less (a) than six (6) months or a fine of not less than ₩100,000.00 or both.
 - for any subsequent offence, to a term of imprisonment of (b) not less than one (1) year, or a fine of not less than ₩150,000.00 or both.
- 9. Where a person is convicted of an offence under Sections 4, 5 Additional Punishment and 6, the Court shall in addition to any punishment order;
 - (a) for the destruction of the meat; and
 - (b) for its or their disposal at the market value and proceeds from such disposal shall be paid into the State Government Treasury Single Account.
- 10. (1) Any Police Officer, Veterinary Officer, Village or Ward Right of entry Head authorized in that behalf by the Director Veterinary Service, may at any time enter any premises in which he has reason to believe that an offence under Sections 4, 5 and 6 has been or is being committed.
 - (2)Any person or official referred to in Section 10 (1) shall arrest any vehicle found within the State carrying donkeys without permit and be taken to the nearest Police Station.
- 11. Any person who obstructs or otherwise prevents the entry into Penalty for Obstruction any premises by any person referred to in Section 10, commits an offence, and shall be liable on conviction, to a fine of not less than ₩50,000.00 or to imprisonment for a term of not less than three (3) months or both.

Any Court in the State shall summarily try all offenders arraigned and impose sanctions, and make such orders as necessary or expedient.

Jurisdiction

14. The Kaduna State Transportation, Trade and Slaughter of Repeal Donkeys (Prohibition) Law, No 2 of 2000 is hereby repealed.
