
A LAW TO REPEAL THE KADUNA STATE PUBLIC SERVICE INSTITUTE (KAPSI) LAW, 2017

Savings, etc

BE IT ENACTED by the House of Assembly of Kaduna State as follows:

- 1. This Law is cited as the Kaduna State Public Service Institute Short Title (Repeal) Law, 2017.
- 3. The statutory functions, rights, obligations, and liabilities of the Kaduna State Public Service Institute existing before the commencement of this Law under any contract or instrument, whether in Law or equity, shall by virtue of this Law and without further assurance, be vested in Kaduna State University.
- 4. Any such contract or instrument mentioned in Section 3 shall be of the same force and effect against or in favour of the Kaduna State University and shall be enforceable against it, instead of the Kaduna State Public Service Institute existing before the commencement of this Law, as if the Kaduna State University had been named therein or had been a party thereto.
- 5. The Kaduna State University shall be subject to all obligations and liabilities to which the Institute existing

before the commencement of this Law was subject to, and all persons shall have the same rights, powers and remedies against the Kaduna State University as they had against the Kaduna State Public Service Institute.

- 6. Any proceedings or cause of action pending or existing immediately before the commencement of this Law, by or against the Kaduna State Public Service Institute before the commencement of this Law in respect of any right, interest, obligation or liability may continued or as the case may be, commenced by or against the Kaduna State University and any determination of a court, tribunal or other authority or person may be enforced by or against the Kaduna State University to the same extent that such proceedings or cause of action or determination might have been continued, commenced or enforced against the Institute.
- 7. Any person:
 - (a) who immediately before the coming into force of this Law was the holder of any office or staff of the Institute before the commencement of this Law shall, on the commencement of this Law and without further assurance, continue in office and deemed to have been appointed to the office by the Kaduna State University.
 - (b) whose services are not required by the Kaduna State University upon the conduct of such needs assessment for the effective performance of its functions in accordance with this Law shall be redeployed to the Kaduna State Civil Service.
- 8. The Kaduna State Public Service Institute Law No. 14, 2014 Repeal is hereby repealed.
