EKITI STATE OF NIGERIA

WHEREAS:

1. The Ondo State College of Education, Ikere-Ekiti, renamed, the College of Education Ikere-Ekiti pursuant to Ekiti State Change of Certain Institutions Names Law No.3 of 1999, was upgraded into a University of Education, Ikere-Ekiti under the University of Education, Ikere-Ekiti Law No.10 of 2007, whereby the Ondo State College of Education, Ikere-Ekiti Edict, 1990 establishing the College was repealed by the said University of Education, Ikere-Ekiti Law, No.10 of 2007.
2. Ekiti State Government has decided to consolidate all the three Universities in Ekiti State including the University of Education, Ikere-Ekiti and has therefore repealed the Law establishing the University of Education, Ikere-Ekiti.





AND WHEREAS, on the repeal of the University of Ikere-Ekiti Law No.10 of 2007 under the Ekiti State Consolidation of Universities Law, 2011, the University of Education, Ikere-Ekiti under which the College was subsumed ceased to exist.

THEREFORE, Ekiti State Government has decided to restore the College by reviving the Law establishing it through the enactment of this Law.

ENACTED BY THE HOUSE OF ASSEMBLY EKITI STATE AS FOLLOWS:

Restoration of College of Education, Ikere-Ekiti

1. The Ondo State College of Education, Ikere-Ekiti Edict, 1990 repealed by the University of Ikere-Ekiti Law No. 10 of 2007 is hereby revived.

Citation

2. This Law may be cited as Ekiti State restoration of College of Education, Ikere-Ekiti Law, 2011.
