**ENACTED BY THE EKITI STATE HOUSE OF ASSEMBLY AS FOLLOWS:**

*Title*            1.        Amendment of the Title.

The Title of the law is hereby amended by replacing the entire title with “Ekiti State Multipurpose Credit Agency Law”.

*Governing* 2.            Amendment of Section 2 (2) (A) & (C) of the Principal Law.

*Council*





Section 2 (2) (a) of the law is hereby amended by adding the words “on full time” to now read “A Chairman on full time”

Section 2 (2) (c) of the law is hereby amended by deleting the words “on the recommendation of the Commissioner” and substituted with one part time basis, to now read “ three other members appointed by the Governor on part time basis”

*Tenure* 3. Amendment of Section 3 (4) of the Principal Law. Section 3 (4) of the Principal Law in hereby expunged.

*of office*

*General* 4. Amendment of Section 6 (1)-(5) of the Principal Law.

*Manager* Section 6 (1) of the Principal Law is hereby amended  
*of the Agency* deleting the entire section and replace with “There shall be for the Agency, a General Manager to be appointed by the Governor”

Section 7 (1) (i) of the Principal Law is hereby amended

*the Agency*

by including “through the Civil Service Commission” to now read: “the Council shall have power to appoint staff through the Civil Service Commission, transfer or second from the Public Service in the State, such number of employees as may, in the opinion of the Council, be required to assist the Agency in the discharge of any of its functions under this Law.”
