PENSION LAW (NO. 7 OF 2010)**

ENACTED BY THE STATE HOUSE OF ASSEMBLY AS FOLLOWS:-

**Amendment of Sections 13(1) a and b, 13(2), 23 (1) (a), 23 (1) (c), 23 (1) (d)
S.24(a), 23(1) (c), 23 1 (d) S. 24 (1) and section 26 of the Principal Law.**

1. Sections 13(1) (a) and (b) of the Principal Law are hereby amended by deleting fifteen percent and substituting therefore the word 'seven and half percent' Section 13(2) of the Principal Law is hereby amended by deleting '15%' and substituting therefore the word '7¹/2%'.

2. Sections 23 (1) (a), 23 (1) (c), 23 1 (d) and S.24 (a), 23 (1) (c), 23 1 (d)





S.24 (1) and Section 26 of the Principal Law are hereby amended by deleting the word ‘part-time’ wherever it appears in those sections and substituting therefore the Word “full-time”.

Amendment of S.23 (1) (b) and S.23 (4) of the Principal Law.

3. Sections 23 (1) (b) and S.23 (4) of the Principal Law are hereby amended by deleting the word “Director-General” whenever it appears in those sections and substituting therefore the word “Secretary”.

4. This law may be cited as Ekiti State Contributory Pension (Amendment) Law, 2011.
