Commencement

ENACTED by the National Assembly of the Federal Republic of Nigeria-

1. The Water Resources Act Cap. W2, Laws of the Federation of Nigeria, 2004 (in this Act referred to as "the Principal Act") is amended as set out in this Act.

Amendment of Cap. W2 LFN, 2004

1. Section 18 (1) of the Principal Act is amended by substituting for -

- (a) the expression -
 - (i) "N2,000" in line 3, the expression, "N500,000", and
 - (ii) "N100", in line 5, the expression, "N2,000"; and
- (b) the words, "six months", the words, "one year".
- 2. This Act may be cited as the Water Resources (Amendment) Act. 2016.
