

ENACTED by the National Assembly of the Federal Republic of Nigeria-

- 1. The National Crop Varieties Livestock Breeds (Registration, Etc.) Act Cap N27. Laws of the Federation of Nigeria, 2004 (in this Act referred to as "the Principal Act") is amended as set out in this Act. Amendment of Cap. N27 LFN. 2004
- 2. Section 8 of the Principal Act is amended – Amendment of section 8
  - (a) in subsection (2), by substituting for the expression, "N200", in line 2, the expression, "N100,000"; and
  - (b) in subsection (3), by substituting for the expression, "N5,000", in line 5, the expression, "N500,000".
- 3. This Act may be cited as the National Crop Varieties and Livestock Breeds (Registration, Etc.) (Amendment) Act, 2016. Citation.
