INTRODUCTION

Visa has become one of the key tools used by nations to spur economic growth, enhance security and national development. The impact of a right visa policy on security, promotion of investment, creation of employment, technological advancement as well as economic growth and development of any nation cannot be overemphasised. This is the reason nations are constantly becoming creative and competitive with their visa policies and programmes in order to reap the full benefits.

The Nigeria Visa is an instrument for control of entry and exit of migrants. The Nigeria Visa Policy 2012 was a good effort by the Federal Government of Nigeria in realigning the visa policy to meet the reality of the ever-changing socio-economic and politically globalized world. The policy evolved from a restrictive and complicated entry formalities to a liberalized and more investment friendly policy tailored towards being one of the most developed nations in Africa and in the world in general.

The Nigeria Immigration Service is saddled with the responsibility for the implementation of Nigeria's visa regime. The Nigeria visa policy outlines the expectations of the Immigration Act 2015 and the Immigration Regulations 2017 with respect to administration of visas in Nigeria. In view of the partial successes of the Nigeria Visa Policy 2012, there arose a need to complete the implementation of the document and the opportunity to reflect current global best practice.

The Nigeria Visa Policy 2020 is a holistic effort by the Federal Government of Nigeria through the Nigeria Immigration Service and relevant stakeholders. The contents may be summarised as follows:

- i. Introduction of 3 categories of visas known as Short Visit visas, Temporary Residence visas and Permanent Residence visas as well as the expansion of visa classes from 6 to 79 as shown below:
 - Short Visit Visas 28 classes
 - Temporary Residence Visas 36 classes
 - Permanent Residence Visas 15 classes

- ii. A visa for every conceivable purpose and unbundling of the single Residency Visa to 36 classes;
- iii. Review of the visa application processes to include Embassies, Visa Application Centers, Visa on Arrival and the introduction of electronic Visa (e-Visa). While the e-Visa is a web based/online application process that is subject to pre-approval before arrival to Nigeria, the Visa on Arrival (VOA) is not subject to pre-approval but can be issued at point of entry;
- iv. Visa on Arrival for holders of passports of African Union Member States to enable short visits;
- v. Visa on Arrival for tourism to citizens of all countries:
- vi. Visiting visas for family and friends to come to Nigeria. Strictly to be issued at the Embassies;
- Visa classes for Nigerians in the diaspora with dual citizenship. Nigerians by birth who renounced Nigerian citizenship as well as Nigerians by birth who use/hold the national passport of other countries (eg infants born abroad);
- viii. Visa codes for each of the 79 visa classes to ease processing; and
- ix. Automation of the TWP application submission process through the e-Visa system;

The Nigeria Immigration Service has emplaced mechanisms for the seamless delivery of these visa services at various issuance centres such as visa desks, embassies, visa application centres and ports of entry. We intend to deliver these services through a people-oriented, effective and efficient Immigration Service, manned by well trained and motivated workforce as we strive to strengthen the security and prosperity of Nigeria through humane, proactive, effective and efficient border security and migration management.

The NIS is poised to ensure control of migrants before entry, on entry and after entry into Nigeria. Appropriate equipment have been deployed at various visa processing centres and ports of entry for security clearance. Furthermore, it would involve extensive training for NIS officers and relevant stakeholders on their expected roles, to ensure prompt visa service delivery. I therefore urge all officials to live up to expectations.

I hereby wish to use this opportunity to express appreciation to Mr President and the Honourable Minister of Interior for the support, encouragement and provision of an enabling environment. I equally wish to acknowledge officials from the NIS and other Ministries, Departments and Agencies for their professionalism and contributions towards the Nigeria Visa Policy (NVP) 2020.

MISSION

Visa Application Channels are medium through which Nigerian visas can be processed and obtained. The available Visa Application Channels are:

- i. Visa on Arrival
- iii. Electronic Visa (e-Visa)
- iii. Visa at the Embassy



VISA ON ARRIVAL

The Visa on Arrival (VoA) service is a visa application process that allows certain holders of passports of other nationalities to obtain visa upon arrival at the point of entry in Nigeria.

"...The Comptroller General of Immigration shall authorise the issuance of Short Visit Visas at the port of entry..." (Immigration Act 2015, Sec. 20(7))

"Upon application in the prescribed manner, the Comptroller General may approve the issuance of visa on arrival in respect of any person and such person shall be allowed entry through the designated port." (Immigration Regulation 9)

Classes of Visas available for Visa on Arrival

- F4C Business Frequently Travelled Executives Visa
- **F5A:** Tourism Visa;
- F7K: Emergency Relief Work Visa
- F9A: Returning holders of other National Passports who are Nigerians by birth; and

Visa on Arrival for Citizens of African Union Countries

The Nigerian Government introduced Visa on Arrival services for **holders of Passports of African Union Countries** for short visits and not permitted for employment.

Eligibility for Visa on Arrival

- Citizens of countries who fall within the categories of persons eligible for F4C, F5A, F7K and F9A visas
- Holders of Passports of African Union countries

How to Apply for Visa on Arrival

- i. Apply for Visa on Arrival at the Nigerian port of entry by proceeding to the desk marked 'Visa on Arrival'
- ii. Make payment online via the website (www.immigration.gov.ng) and print payment receipt
- iv. Next is biometric enrolment and issuance of entry Visa.

Basic Requirements for VoA

- Valid Passport with minimum of six months validity
- Valid return ticket

e-VISA

Nigeria e-Visa service is an online visa application process that enables intending visitors to Nigeria to apply and obtain electronic approval for short visit visas not more than 3 months online. e-Visa is subject to online pre-approval (Travel Authorisation Letter) before arrival to Nigeria.

- F3B Transit Visa
- F4A: Business Visa (Single Entry);
- F4C: Business (Frequently Travelled Executives)
- F5A: Tourism Visa:
- F7A Journalist Visa
- F7C: Medical Tourism Visa
- F7D: Religious Tourism Visa
- F7E: Sports Visa
- F7F: Artist(e)/Entertainer/Musician Visa

- 7G: Study Tour Visa
- F7H: Academic Exchange Programme Visa
- F7I: International Cultural Exchange Visa
- F7J: Humanitarian Services Visa
- F7K: Emergency/Relief Work Visa
- F7L: Staff of INGO Visa
- F7M: Staff of NGO Visa
- F9A: Returning holders of other National Passports who are Nigerians by birth

How to Apply for e-Visa

- i. Apply for e-Visa on online at www.immigration.gov.ng by selecting applicable visa class/type in the Short Visit Visa Category listed
- ii. Complete application, upload requirements and make payments
- iii. Once application is submitted successfully, a printable receipt would be issued, with another copy sent to your email. (Successful submission is not an approval)
- iv. The application would be processed, after which, an Approval confirmation and Electronic Travel Authorisation Letter (eTAL) would be sent to your email within 48hrs (2 working days).
- vi. Proceed to Nigeria with eTAL

Basic Requirements for e-Visa

- Passport valid for at least 6 months with at least 2 blank visa pages for endorsement
- Return ticket
- Evidence of sufficient fund
- Evidence of Hotel Reservation/host address in Nigeria

Eligibility

 Citizens of countries who fall within the categories of persons eligible for classes of visas listed for e-Visa services above.

VISA AT THE EMBASSY

All classes of Nigeria Visas including those available for Visa on Arrival and e-Visa services can be processed and obtained at the Nigerian Embassies and Visa Application Centres. However, all classes of visas for Temporary and Permanent Residence Visas can only be processed and obtained at the Embassies or Visa Application Centres. Embassy includes any Nigerian High Commission or Consulate.

The process for obtaining visa at the Embassy include:

- application and payment online at <u>www.immigration,gov.ng</u>;
- submission of required documents at the Embassy;
- attend interview (where necessary and applicable);
- obtain visa.

The Nigeria Visa processes now also include the acquisition of biometrics of Nigerian visa holders at the Embassy or at point of arrival. The biometric acquisition of visa applicants is to be extended to all visa issuance centres.

Visa Application Centres (VAC)

Applications for Nigeria Visas can also be submitted and processed through established Visa Application Centres (VAC) operating in some countries. The centres receive and submit applications on behalf of visa applicants to the Nigerian Embassies for processing and approval.





NIGERIA VISA CATEGORIES

VISA CATEGORIES

Nigeria Visas are categorised as follows:

- i. Short Visit Visa (SVV)
- ii. Temporary Residence Visa (TRV)
- iii. Permanent Residence Visa (PRV)

Short Visit Visa

Short Visit Visas allow travellers to visit Nigeria for a period not exceeding three months for the purpose of visit, tourism, business meeting, conference, seminar, contract negotiation, marketing, sales, purchase, distribution of Nigerian goods, Trade Fairs, job interview, sports, entertainment, study tour, academic exchange programme, humanitarian services, relief/emergency works and temporary work permits.

Temporary Residence Visa

Temporary Residence Visas allow individuals reside in Nigeria for a period not exceeding two years, subject to renewal, for the purpose of employment, establishment, schooling, internship, accompanying employed migrants or students or diplomats as dependants.

Permanent Residence Visa

Permanent Residence Visas permit certain class of individuals to obtain permanent residence status in Nigeria. These individuals include Spouses of Nigerian citizens, Nigerians by birth who renounced Nigerian citizenship, and their spouses; as well as investors who import an annual minimum threshold of capital as may be specified, highly skilled individuals as well as some categories of retirees.



VISA FREE/ EXEMPTION

1.ECOWAS Member States - F1A

Citizens of the following ECOWAS Member States do not need to acquire a Nigerian Visa to enter Nigeria based on ECOWAS Free Movement Protocol:



Entry Conditions

The citizens of the above listed countries:

- require valid travel document to enter Nigeria
- must enter Nigeria through a recognised entry point
- must have means of sustenance while in the country
- must not be in the category of Prohibited Immigrants
- free entry for maximum of 90 days is not valid for employment.
- Residence Permit must be obtained to get employment or establish business

2. Visa Abolition Agreement Countries - F1B






- i. The right to reside is not an automatic right to work.

- iii. Visa on Arrival is not visa free, it is a process of obtaining a visa.
- iv. Each visa application shall be treated on its merit.
- v. All Visa requests are subject to passport validity.
- vi. All dependent cases are subject to validity of principal's Work/Resident Permit.
- vii. All visa requests can be processed at the Embassy. "Embassy" includes any Nigerian High Commission or Consulate.
- viii. Each application letter for visa shall include acceptance of Immigration Responsibility
- ix. Holders of Nigeria work and residence permits are entitled to multiple entries.
