AGRICULTURAL PRODUCE

RULES

Title.

1. These Rules may be cited as the Agricultural Produce Rules.

Form of application.

2. Application for a dealer's licence shall be made in the form prescribed in Form No. 1 of Schedule I.

Form of dealer's licence.

3. A dealer's licence shall be issued in one of the forms prescribed in Form No. 2 of Schedule I.

4. The fees payable under the provisions of the Decree shall be those prescribed in Schedule II:

Provided that no dealer shall be required to pay more than one fee in respect of the same place of business.

Form of Permit.

5. The permits for the removal of agricultural produce shall be in the form prescribed in Form No. 3 of Schedule I, shall be printed by the Government and shall be issued in books, each book containing 100 permits numbered consecutively with counterfoils.

Conditions as to use of permits.

6.—(1) Permit books shall be retained by the persons to whom they have been issued and all particulars required to be filled in shall be filled in both in the foil and counterfoil and the foil and the counterfoil so filled in shall be signed by such persons before the permits are handed over for the purpose of removal of produce.

(2) No blank permit shall be issued.

(3) Not more than one permit shall be issued to any one person at one time.

(4) *The fee* No charge shall be made for the issue of *such* permits *shall be 20 Ck.*

(5) The person to whom a permit book shall have been issued shall return the book containing counterfoils to the office of the person who shall have issued such book, within seven days of date of the issue of the last permit contained in such book.

(6) No permit, if spoiled while filling it up shall be destroyed but both the foil and counterfoil of such spoiled permit shall be kept in the permit book and returned together with the book as aforesaid.

Conditions of issue of permit books.

7.—(1) Persons authorised by the Licensing Officer to issue permit books shall explain to every person to whom such books are issued the provisions of rule 6.

(2) A list of the names and addresses of the persons to whom permit books are issued shall be kept and the number of books issued together with the serial numbers of the permits therein shall be entered in such list against the name of the person to whom the books are issued and the signature or thumb print of such person shall be taken against such entry. Any book returned by a person shall be checked with the entry relating thereto in the list and the particulars of the book so returned shall also be entered.

(3) It shall be the duty of the persons authorised as aforesaid to keep a proper account of all the permit books issued by them and if authorised by the District Commissioner in writing in that behalf to call upon the persons to whom permit books have been issued to produce such books for inspection for the purpose of carrying out a check.

8. No permit shall be necessary for the removal of coconuts not exceeding four in number or copra derived from an equal number of coconuts in the possession of any one person. Removal without permit.

9.—(1) No person shall—

- (a) solicit, demand or accept any payment in money or in kind for the issue of a permit; or
- (b) issue any blank permit with intent that it be used by any other person; or
- (c) knowingly enter any false particulars in a permit; or
- (d) wilfully omit to enter any prescribed particulars in a permit issued by him.

Offences and penalties. G.N. 175 of 1949.

(2) Any person who contravenes any provision of this rule shall be liable to a fine not exceeding one hundred shillings.
