THE WILDLIFE CONSERVATION (AUTHORISED OFFICERS)
(IDENTITY CARDS) REGULATIONS, 2012

Citation

1. These Regulations may be cited as the Wildlife Conservation (Authorized Officers) (Identity Cards) Regulations, 2012.

Authorized
Officers to carry
Identity Card

2.-(1) An authorized officer under the Wildlife Division and every person appointed by the Director under the provisions of section 3 of the Wildlife Conservation Act shall, at all times during the execution of his functions, carry an identity card in the form prescribed in the Schedule to these Regulations.

(2) Without prejudice to the provisions of sub-regulation (1), an Authorised Officer, other than a village game scout, not working under the Wildlife Division shall carry their respective institutional Identity

Cards while exercising the functions of an authorized officer under the Wildlife Conservation Act.

Surrender of Identity Cards

3. An authorized Officer working under the Wildlife Division or persons appointed by the Director shall, upon ceasing to be an authorized officer, surrender his identify card to the Director.

Loss or destruction of Identity Cards

4. Any authorized officer who loses his identity card or whose identity card is destroyed or defaced shall as soon as possible, submit the destroyed or defaced identity, or as the case may be, a police loss report of the lost identity card to the Director who may issue a new identity card.

Registration of Authorized Officers

5. The Director shall maintain a register of all authorized officers working under the Wildlife Division or persons appointed by him in which shall be recorded the name of the officer and the particulars of the identity card issued to such authorized officer.

Revocation of GN. No. 270 of 1974

6. The Wildlife Conservation (Authorized Officers)(Identify Cards) Regulations are hereby revoked.

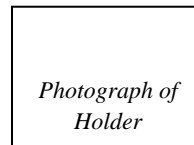
